**ORDINANCE No.**

**AN ORDINANCE OF THE COUNTY OF SIERRA AMENDING PART 11, CHAPTER 08, SECTION 010 OF THE SIERRA COUNTY CODE ESTABLISHING SPEED LIMITS.**

**THE BOARD OF SUPERVISORS OF THE COUNTY OF SIERRA ORDAINS as follows:**

**Ordinance Section One:** Part 11, Chapter 08, Section 010 of the Sierra County Code is hereby amended to read as follows:

**Chapter 11.08 – SPEED LIMITS**

**Section: 11.08.010-15 Miles Per Hour**

Sierra County Code, Section 11.08.010 is amended to add the following County Roads and as such, shall establish a speed limit of fifteen (15) miles per hour:

- N. In Sierra City, County Road 581, Ostrom Way, from its intersection with 49er Drive/Wild Plum Ridge Road to its intersection with Wild Plum Road.
- O. In Sierra City, County Road 580, 49er Drive, from its intersection with Lewis Lane to its intersection with Ostrom Way/Wild Plum Ridge.
- P. In Sierra City, County Road 530, Old Highway 49, from its intersection with Wild Plum Road to its end.

**Ordinance Section Two:** This ordinance shall take effect thirty (30) days after its passage. Before the expiration of fifteen (15) days after passage of this ordinance, it shall be published once with the names of the members of the Board of Supervisors voting for and against the ordinance in The Mountain Messenger, a newspaper of general circulation published in the County of Sierra, State of California.
