**WHEREAS**, the Sierra County Board of Supervisors and the Sierra County Fire Safe Council have lead roles in protecting the local community against wildfire, drought flood, and extreme heat events; and,

**WHEREAS**, the Sierra County Board of Supervisors recognizes that the County has a need for an updated Local Hazard Mitigation Plan and updated Safety Element to the General Plan; the Community Wildfire Protection would fund such efforts.

**WHEREAS**, the referenced project would update the Local Hazard Mitigation Plan; update the General Plan Safety Element to address current statutory requirements; better prepare Sierra County to be aware of and respond to new climate vulnerabilities; and return the local jurisdiction to a state of compliance with statutory requirements.

**NOW THEREFORE BE IT RESOLVED** that the Sierra County Board of Supervisors strongly endorses the Sierra County Fire Safe Council's application for the Community Wildfire Protection Grant.
