**RESOLUTION OF APPRECIATION

WHEREAS, Vickie Clark, announced her retirement as Director of the Sierra County Department of Health and Social Services after a tenure of five years in this position; and,

WHEREAS, Vickie Clark, was appointed to this position on May 2, 2017 and commenced work on July 5, 2017; and,

WHEREAS, the duties of the Director of the Sierra County Department of Health and Social Services include varied and responsible programs, including the administration of public assistance, child protective services, adult protective services, In Home Support Services, as well as administration of the county Department of Public Health and administration of the Department of Environmental Health; and,

WHEREAS, during this tenure, Vickie Clark oversaw the five year County Self-Assessment for Child Welfare, served as a member of the Child Abuse Prevention Council, and selflessly engaged with the community based Family Resource Center; and,

WHEREAS, during any period of time the duties of the Sierra County Director of Health and Social Services is sought with any number of critical issues, Vickie Clark, in her tenure, oversaw the operation of the Public Health Department during a 30 month public health emergency pandemic, the likes of which has not been seen in the last century, and did so in a manner that both protected the public health and respected the lives of all within the county; and,

WHEREAS, in addition to all the above, Vickie, has undertaken all her professional responsibilities in a calm and cheerful manner, unflappable, and without complaint, has been a valuable and extraordinary resource on any number of local emergency responses within Sierra County; and,

WHEREAS, Vickie Clark, is held in high esteem of all her Sierra County colleagues; and

WHEREAS, Vickie Clark, during her five year tenure as director oversaw an organization that provided services with professionalism, compassion, and in a manner that represented the best in Sierra County.
