SIERRA COUNTY CITIZENS COMMITTEE FOR SOLID WASTE/LOCAL TASK FORCE – 5 Vacancies

The Sierra County Citizens Committee for Solid Waste/Local Task Force was established to make reports and recommendations to the Board of Supervisors on waste disposal matters; recommend policies to the Board of Supervisors which may affect the Sierra Regional Agency; participate in the "Five Year Review" of the Countywide Integrated Waste Management Plans and to serve as the "Solid Waste Appeals Committee" as outlined in County Resolution 91-77 adopted May 7, 1991.

The committee is comprised of two (2) members of the Board of Supervisors appointed by the Chairperson of the Board, a member from the Loyalton City Council to be appointed by the City Council, the County Director of Transportation, the County Solid Waste Fee Administrator, three (3) Business owners appointed by the Board of Supervisors, three (3) Public Members appointed by the Board of Supervisors, a representative of the United States Forest Service appointed by the Forest Supervisors, and one (1) member who shall be a private refuse hauler operating within the County.

The committee is currently seeking three (3) Business Owner Representatives and two (2) Public Member Representatives to serve a three year term.

APPOINTMENTS will be made at the next appropriate meeting of the Sierra County Board of Supervisors.
