**WHEREAS**, Mary Piggott Johnsen, and her husband, Lt. Col. John Johnsen, USA, retired to Downieville in 1997; and,

**WHEREAS**, both became active community volunteers in their 16 years as residents of Downieville; and,

**WHEREAS**, Mary's involvement in the Sierra County community included service on the Western Sierra Residential Center board, service as the treasurer of the Golden Rays Incorporated Seniors organization, service as a member of the Sierra County Mental Health Advisory committee, service as a Downieville Schools GATE advisor, organizer of the Downieville community Veterans Day memorials, and a decades long column writer for the Mountain Messenger newspaper; and,

**WHEREAS**, with the completion of the new Tennis courts in Downieville on county property on Hospital Flat, Mary organized a community tennis program for all ages, but especially designed for school age kids that she mentored for over a decade, a program that continues to this day and for which she will always be remembered.

**NOW THEREFORE**, the Sierra County Board of Supervisors, on behalf of the citizens of Sierra County, do recognize Mary Piggott Johnsen and hereby dedicate the Downieville Community Tennis Courts in her honor.
