**IN THE MATTER OF
AUTHORIZING THE AUDITOR
TO MAKE CERTAIN TRANSFERS**

WHEREAS, pursuant to Government Code §29125, the Board of Supervisors may increase revenues and expenditures;

WHEREAS, budgeted revenue for the Public Health Realignment account was submitted as \$526,716 for the 18/19 Fiscal Year;

WHEREAS, the transfer authority adopted in the final budget was set at \$451,082 for the 18/19 Fiscal Year, a difference of \$75,634;

WHEREAS, the roll-forward from the 17/18 Fiscal year of \$115,694 was not included in the final budget as funds available for expenditure in the 18/19 Fiscal year;

NOW THEREFORE BE IT RESOLVED, the Sierra County Board of Supervisors authorizes the Auditor to make the following adjustment to the 2018/2019 County Budget:

Increase Expenditures:	Public Health 91 Realignment	8170000-7600	\$191,328
Increase Revenue:	Public Health Operating Account	0515610-4711	\$191,328
