**Background Information:** Currently Sierra County contracts with Clean & Sober Recovery Services for detoxification services and recovery home services. Right now our other contracted providers for residential recovery home services has a wait list to get clients in. Sierra County wishes to increase the contract amount by \$59,800.00 to meet the needs of the clients so that they may continue with their recovery process. Clean & Sober Recovery Services has agreed to lower their recovery home services rate to \$180.00 per day, per client from \$195.00 per day, per client.

**Alternatives or Impacts of disapproval:** Sierra County would not be able to meet the requirements set forth by the state.
