Sierra County Local Child Care Planning Council - (1 Vacancy)

The Local Child Care Planning Council identifies local priorities for child care and the development of policies to meet the needs identified within those priorities. The Council is comprised of 20% of the membership shall be consumers, 20% of the membership shall be child care providers, reflective of the range of child care providers in the county, 20% of the membership shall be public agency representatives, 20% of the membership shall be community representatives, who shall not be child care providers or agencies that contract with the department to provide child care and development services, and the remaining 20% shall be appointed at the discretion of the appointing agencies.

One (1) vacancy currently exists on the Sierra County Local Child Care Planning Council.
