**Adding Subsection (w) to Part 11, Chapter 12 of the Sierra County Code
Pertaining to Parking Regulations in Downieville**

THE BOARD OF SUPERVISORS OF THE COUNTY OF SIERRA ORDAINS as follows:

Ordinance Section One: Part 11, Chapter 12, Section 020, Subsection (w), is hereby added to read as follows:

(w) Parking is restricted to a twenty four (24) hour limit on the easterly and westerly sides of Durgan Flat Road (County Road 503) from the intersection of Nevada Street (at the southeast corner of lot 5 and southwest corner of lot 13 of the Downieville Townsite Map) southerly to its end at the entrance to the US Forest Service Downieville Trailhead parking facility.

Ordinance Section Two: This ordinance shall take effect thirty (30) days after its passage. Before the expiration of fifteen (15) days after passage of this ordinance, it shall be published once with the names of the members of the Board of Supervisors voting for and against the ordinance in the Mountain Messenger, a newspaper of general circulation published in the County of Sierra, State of California.
