BACKGROUND INFORMATION: The Golden Rays and local Senior Groups currently use the Downieville Community Hall for lunches during weekdays and also for occasional games (bingo, cards, etc) and socialization. This includes use of the kitchen within the community hall. During discussions on the remodeling of the community hall through use of State grants and other funds, the use of the hall by seniors was discussed-both from the view of planning for space utilization as well as possible donations toward improvements that would be compatible with present and future senior use. This item is a request for direction from the Board of Supervisors to return on March 16, 2021 with a resolution waiving daily use fees by the senior groups for its lunch program and for interim and occasional games and socialization.
